We are reaching out to inform you that our pest control company has been enlisted by the management of your building to conduct a necessary pest control service specifically targeted at addressing any **COCKROACH** infestations in your living space. This proactive measure is essential for maintaining a clean and hygienic environment for all residents.

Our team from Pestlink will be visiting your premises on _____ at _____ to carry out the required treatment. To ensure the effectiveness of this procedure, it's imperative that you temporarily vacate your premises until _____. To facilitate our Pest Management Professionals and ensure the thoroughness of the treatment, we kindly request your assistance with the following detailed instructions:

Kitchen and Bathroom Preparation:

- Empty all contents from kitchen cupboards, drawers, refrigerator tops, stovetops, countertops, and bathroom vanities.
- Place these items on your kitchen table, covering both the table and the items with plastic sheeting or blankets to protect them during treatment.

Appliance Adjustments:

- Move the refrigerator and stove away from the wall to allow access to treatment.

Electrical Coverings:

- Remove electrical outlet switch plate covers, phone jacks, cable outlets, and light switch covers to ensure full coverage during treatment.

Closet and Linen Cupboard Precautions:

- Clear shelves and floor perimeters in all closets and linen cupboards. Items from these spaces can be placed on beds without requiring covering.

Pet and Plant Considerations:

- Remove all pets, including birds, from the premises during treatment. Cover fish tanks and turn off pumps to prevent any harm.
- Plants should be removed from windowsills and adequately covered to protect them.

Furniture Adjustment:

- Move furniture in all rooms at least 2 feet away from the walls and towards the centre of the room. This adjustment allows our team access to baseboards for thorough treatment.

Temporary Evacuation:

- All occupants must leave the premises for a minimum of 4 to 6 hours after treatment. Individuals with specific health conditions such as allergies, asthma, pregnancy, children under 4 years old, or respiratory problems are advised to stay away for 12 to 24 hours.

Upon returning to your premises, please adhere to the following post-treatment guidelines:

Cleaning Procedures: Wash kitchen countertops, breadboards, refrigerator, and stovetops with soap and water. Avoid cleaning cupboard shelves and drawers.

Temporary Protection: Use paper to line shelves and drawers for at least three weeks following the treatment to provide continued protection against potential pests.

Bait Placement: Leave cockroach bait in its applied locations for up to 35 days to ensure the effectiveness of the treatment.

Expected Outcome: It's common to observe an increase in roach activity immediately after treatment as they become disoriented and perish shortly after that.

Please note that the landlord or building owner is responsible for informing all affected tenants about this necessary treatment.
